

The [Department of Education's Federal Regulations 34 CFR 668.43 \(a\)\(5\)\(v\)](#) mandate that each institution inform students of whether their program curriculum, both distance education programs, and face-to-face programs, meet the state requirements for each program that leads to licensure or certification.

In compliance with this regulation, this document provides Missouri Western State University's assessment of the physical therapist assistant (PTA) curriculum and ability to meet the requirements for professional PTA licensure in other states.
